#### Telethon and Build Now Foundation Cubby Challenge

Telethon and Build Now Foundation 6 cubbies in 6 hours Challenge "Cubby Challenge" is run and promoted by Channel 7 Telethon Trust (**Telethon**), of 50 Hasler Road, Osborne Park 6017 and Build Now Foundation, of 580 Murray St, West Perth WA 6005. Any questions in relation to the "Cubby Challenge" should be directed to us as the Promoters at these addresses.

We reserve the right to update these **Terms** at any time and for any reason.

#### **CONDITIONS OF ENTRY**

By submitting a nomination for the Cubby Challenge, you agree to be bound by these Terms.

If you are nominating someone other than yourself, you must bring these Terms, and our **<u>Privacy Policy</u>**, to the attention of that person and get their consent to their entry into the Cubby Challenge, prior to making any nomination.

#### METHOD OF NOMINATION

To enter, please go to the online <u>Nomination Form</u> and follow the instructions to complete the relevant online nomination form. There is no limit on the number of nominations you may submit.

Nominations that are incomplete or indecipherable may, at our entire discretion, not be valid and may therefore be deemed void. Use of false or misleading information in the Nomination Form or the submission of a nomination contrary to these terms will result in your nomination being invalidated.

Nominations open on 16<sup>th</sup> September 2024 at 00:00 AWST and close on 30th September 2024 at 23:59 AWST (**Closing Date**).

## ELIGIBILITY

The nominated child **is eligible** to enter, and receive a custom cubby, if the nominated child:

- a) is aged between 0 and 15 years of age;
- b) is supported by a service/program or research project of current Telethon beneficiaries (Full List of Telethon beneficiaries <u>here</u>)
- c) lives in Western Australia;
- d) does not have a criminal record in Australia; and/or
- e) their parent or guardian is not an employee of Telethon or our affiliated companies, or an employee of agents or suppliers of Telethon or our holding company or subsidiary companies, who are professionally connected with the Telethon and Build Now Foundation or its administration; or an immediate family member or a member of such people.

It is your responsibility as the person making the nomination to obtain permission from the child's parents or guardian being nominated before submitting a nomination on their behalf. This includes obtaining their permission to include ancillary documents such as photographs of the nominees cubby site location as part of your nomination form.



If you are under 18 years of age, you must have the permission of your parent or guardian to submit a nomination, and if requested by Telethon, you must provide the name and telephone number of your parent or guardian.

We reserve the right to contact the relevant parent or guardian to check the required consents and we can, at our discretion, exclude any nominations for which the requisite consent has not been given.

In addition to any consent that may be required, it is also your responsibility to inform the nominee that they may be required to participate in filming, broadcast and additional publicity related to the Cubby Challenge if they are chosen as a winner.

Our team may contact the nominator, the nominees (and their parent/ guardian, where applicable) to verify facts and/ or events and whether the relevant consents/ permissions have been obtained and, by making a nomination, you acknowledge and agree to this. We do not represent, undertake, or warrant that we will contact all nominators or nominees.

#### NOMINEE SELECTION PROCESS

All valid nominations received by the Closing Date will be considered. A nomination is deemed to be received at the time of its receipt by us and not at the time of transmission.

10 nominees will be shortlisted by Telethon and Build Now Foundation teams based on the selection criteria on the Nomination Form and what we deem are worthy recipients for the special cubby giveaway.

6 nominees will then be selected during the second assessment stage by Telethon and Build Now Foundation teams who will compassionately and thoroughly assess the nominations based on the selection criteria. The 6 shortlisted nominees selected at this stage will be contacted by a Telethon representative.

For further information, please refer to the Nomination Form for information on the selection criteria required as part of the nomination. The selection of nominees at both stages will be entirely at the discretion of Telethon and Build Now Foundation. The decisions made at each stage is final, and we will not enter into correspondence regarding the results.

Assessment of nominations will take place between 1<sup>st</sup> October 2024 and 3<sup>rd</sup> October 2024.

Nominees must be available to be contacted between 9:00am-5:00pm on 4<sup>th</sup> October 2024.

The winners will be notified on 4<sup>th</sup> October 2024 and must be available to attend the Telethon Family Festival live event, broadcasted on Channel 7, and via social media posts on 20<sup>th</sup> October 2024.

If a winner does not claim their prize by 5:00pm 4<sup>th</sup> October 2024, we reserve the right to award the prize to the next best shortlisted nominee, as determined by the Telethon and Build Now Foundation teams during the second assessment stage.

#### FILMING AND PUBLICITY

The winners will be required to make themselves available, as and when requested by Telethon or our broadcast/media partners (with reasonable notice), to take part in filming, broadcast and publicity and/or other contact related to the Cubby Challenge on 20<sup>th</sup> October 2024 either via our social channels or via filming with our broadcast partner and/ or during our in-person event on 20<sup>th</sup> October 2024.



The winners agree that they will not receive compensation for any

participation requested by Telethon, and that they consent to Telethon and our broadcast/ media partners using their name and image in any media in perpetuity, without limitation and without compensation to the winner. Either the winner or, where relevant, their parent or legal guardian will need to provide their signature as proof of waiver and/ or consent to be filmed, such waiver/ and or consent document to be provided by Telethon or our broadcast/ media partner(s).

All winners will be under the age of 15 and if required to engage in any publicity in connection with the Cubby Challenge, and for this reason needs to attend a specific location, the winner must be accompanied by a parent or legal guardian over the age of 18.
