## 'Telethon Hyundai Tucson Giveaway' Terms and Conditions

By entering the **'Telethon Hyundai Tucson Giveaway'** ("the Giveaway"), you are agreeing to the following terms and conditions:

## 1. STANDARD TERMS

- 1.1 Instructions on how to enter, prize details and other information contained within the promotional advertisements and point of sale materials form part of these terms and conditions.
- 1.2 By participating in this Giveaway entrants agree to be bound by these terms and conditions.

# 2. WHO CAN ENTER?

- 2.1 Subject to clause 2.2, entry is open to all residents of Western Australia aged who make a donation to the Channel Seven Telethon Trust during the 2022 live Telethon broadcast ("Telethon") during the Giveaway Period. To avoid doubt individuals who donate on behalf of a business that carries on commercial activity of an nature are not eligible to enter the Giveaway or win the Prize.

- 4.1 To enter and win the Giveaway entrants must donate to the Telethon during the Giveaway Period using the online form found at <a href="https://www.telethon7.com/donate">https://www.telethon7.com/donate</a> or by calling 1300 737 507 and donating via direct debit or credit card payment and providing the required personal details during the Giveaway Period (to avoid doubt participants who pledge to donate only during the Giveaway Period or donate outside of the Giveaway Period are not eligible to enter or win the Giveaway).
